

PHASE TWO SUMMARY

AUGUST 2016

AIM

Phase Two of Alcoa's community engagement process, which ran from the 8th – 26th August, heard the community's views on the future of the Anglesea mine and power station.

Engagement with the community during Phase Two was focused on testing the expanded Guiding Principles developed in Phase One, to ensure they accurately captured the community's aspirations for the future use of the site.

Community contribution, through the community engagement process, will be a key input into the development of the revised Mine Closure Plan and the draft Masterplan for power station freehold land, which will outline potential future uses of the site.

FEEDBACK RECEIVED

A Community Consultation Network (CCN) workshop was held on Monday 8th August to launch Phase Two. Community feedback was received via the CCN workshop, the discussion forum on the website and email submissions.

Overwhelmingly the feedback on the expanded Guiding Principles during Phase Two was positive and indicated the principles encompassed an overall snapshot of the community's views on how best to utilise the area in the future.

Participants who provided feedback during Phase Two emphasised the need to facilitate future uses that leveraged Anglesea's environmental aspects and atmosphere, while creating ongoing prosperity for the town.

Some of the common feedback collated during Phase Two included:

- Support for recreational opportunities such as a sporting hub or ecologically sustainable activities that provide opportunities for the community to utilise the site;
- Support for tourism opportunities that link the environment, historical and educational aspects of the site;

- Support for the undisturbed lease land to be incorporated into National Park; historical aspects of the site;
- Support for renewable energy opportunities; and
- A desire for limited residential or intensive development.

Considerate of the feedback received during Phase Two, Alcoa will finalise and publish the Guiding Principles in September.

Informed by the Guiding Principles, Alcoa expects to release the revised Mine Closure Plan early in 2017 and the draft Masterplan for power station freehold land late in 2017 for community consultation.
